

#### **GOOD NEWS!**

#### Argentinian Prisoner Featured in Banned Book Action Released

We wrote letters on Pierina's behalf in September.



<u>Pierina Nochetti</u>, a graffiti artist from Argentina who was facing up to 4 years in prison and facing criminal charges of "aggravated damage" for painting graffiti in a protest questioning the disappearance of a young trans man has been released and all criminal charges were dropped. Pierina's case was raised through <u>AIUSA's 2024 Banned Books Week Action</u>.

#### New Individual At Risk Case

Our Group has been selected to work on the cases of Yu Wensheng and his wife Xu Yan in China.

On April 13, 2023, prominent human rights lawyer YU Wensheng and his wife XU Yan were taken into police custody while en route to meet the delegation of the European Union to China in Beijing, where they were to attend a meeting with the EU's Ambassador to China, Jorge Toledo Albiñana, and another senior EU official. In October 2023, Yu and Xu were indicted on charges of "picking quarrels" and "inciting subversion of state power." On October 29, 2024, Suzhou Intermediate Court sentenced Yu Wensheng to three years in prison and Xu Yan, to one year and nine months in prison for "inciting subversion of state power."

We will discuss and start work at our January meeting.


